



Call for Nominations: Fellows of The Combustion Institute

Released: 30 June 2017

Members of the international combustion community recognized by their peers as distinguished for outstanding contributions to combustion, whether it be in research or in applications, may be designated Fellows of The Combustion Institute. This lifetime honorific title confers no special rights, privileges or duties. Fellows are active participants in The Combustion Institute, as evidenced by the publishing of papers in CI affiliated journals, attendance at the International Symposia on Combustion, and/or attendance at CI Section meetings.

Nominations

To be eligible to be nominated, a candidate must have been a member of The Combustion Institute for at least the previous five years. Nominations are submitted by a nominator and two supporters, all of whom must be members of The Combustion Institute. Self-nominations are not accepted. No member of the Fellows Selection Committee may nominate or support a candidate.

Submissions Procedure

Submissions must contain the following items:

- Completed **Fellow Nomination Cover Page** (Microsoft® Word template)
 - ◇ The nominator of a candidate must complete a cover page for The Combustion Institute to accurately process the nomination.
- **Nomination package** (single PDF document), limited to a total of 10 pages maximum (with a font size of at least 10 pt.; 11 pt. or 12 pt. preferred) that contains the following items:
 - ◇ Nominating Letter (two pages maximum)
 - ◇ No more than two support letters (two pages each maximum)
 - ◇ Curriculum vitae; a list of papers published in the past 10 years (2008 and later) in CI associated journals; a list of other selected papers; a statement about involvement in International Symposia on Combustion and CI Section meetings; a citation of at most 20 words (four pages maximum)

Note: CI affiliated journals are: *Proceedings of The Combustion Institute*, *Combustion and Flame*, and *Progress in Energy and Combustion Science*

The **Fellow Nomination Cover Page** and a sample **nomination package template** can be downloaded from the **Fellows of The Combustion Institute** page of the CI website.

Submit the cover page and the nomination package as attachments to an email to: Office@CombustionInstitute.org. The subject line of the submission email should read: "*Fellow Nomination for [Insert Name of Candidate].*" Submissions that do not adhere to these instructions will not be accepted.

Nominations Deadline: Submission must be received before **23:59 EST, 30 September 2017**.

Elected Fellows will be announced in late January 2018. Each nomination remains active for three consecutive years, with the nominator being given the opportunity to update the nomination package.

Automatic Initial Fellows

During this first year of the Fellows Program of The Combustion Institute, fellowship will be conferred automatically on a number of members whose previous levels of recognition place them clearly among the members that the Fellows Program intends to recognize.

Members within the following categories shall be recognized as automatic initial Fellows:

- Gold Medal recipients
- Invited plenary lecturers from past International Symposia on Combustion
- Current and past program chairs of the International Symposia on Combustion
- Current and former editors of Combustion and Flame
- Editors of the Proceedings of The Combustion Institute for volume 32 and higher

To be clear: members within one of the above categories will automatically become Fellows, and so a nomination package is not needed. Questions regarding automatic initial Fellows may be directed to:

Fellows Selection Committee

The Fellows Selection Committee is charged with the responsibility to evaluate nominees each year and select candidates to become Fellows. The committee consists of 12 members appointed by the President in consultation with the Executive Committee. Members of the first Selection Committee have agreed to serve staggered terms over a three-year cycle.
